Saving Family Stories is already proving a hit at Leopold, as this local couple shared with us.

their special day. The recordings last over an hour and capture all the elements of the wedding. Over the years they thought about the wedding and think to re-watch the film but never have the time. When they finally did have the time, technology has moved on.

For 51 years they had only watched the film of their special day once.

#### **Geelong Library and Heritage Centre**

Crafting Carers is a collaboration with Barwon Carer Support to contribute to the Barwon Urban Knitting Community Project. The project involves participants coming together to craft blankets, (or toys, and clothes etc.) during March and May for an exhibition at the Geelong Library & Heritage Centre in June for World Elder Abuse Awareness Day. The aim of the program is to support carers in Geelong to connect and work on a meaningful project together in the library to help support their emotional wellbeing. Crafting Carers runs every fortnight from the ground floor of the Geelong Library and Heritage Centre. From the few sessions so far, attendance is growing with 7 carers registered for the next session.



One of our regulars who has attended every session is an avid knitter/crocheter and is also the full-time carer of their 30 year old daughter Zara, who has Down syndrome. She usually attend Crafting Carers while Zara has appointments or dance lessons and says these sessions are one hour in her week that she gets to spend for herself. She has also taught several people to crochet in these sessions and once spent a whole hour teaching an 80+ year old to tie a slip knot.

We are developing programs that reach the social and tactile needs of adults to compliment our digital and literacy programs. Due to our steadily diversifying community in central Geelong, it's important that the library is inclusive of its offerings regardless of barriers such as language and cognitive ability. Our programs now include a regular monthly knitting and crocheting corner, a monthly collage workshop, and a Conversation Cafe every Monday for practising spoken English.

#### **CONNECTING AND THRIVING: PLACES AND SPACES**

#### **Biyal-A Armstrong Creek Library**

In March the contractors worked on floor finishes, joinery and lighting fixtures. Some of the furnishings were delivered and work outside (landscaping and paving) started.



The library completion is on track and we are working closely with the City of Greater Geelong Executive to confirm an opening date. The collection is being stored by our providers and the community will be thrilled by the new collection currently held by our supplier.

#### **Golden Plains Mobile Library**

Golden Plains Shire successfully applied for a Victorian Government Living Libraries Infrastructure Grant program to purchase and fit out the new mobile library. The new vehicle will replace the unreliable, ageing mobile library which has travelled over 380,000 kms and is becoming expensive to service and difficult to find replacement parts for the 25-year-old vehicle.

Research was undertaken to enable us to select the right type of vehicle to provide a reliable and sustainable library service. A high-roof, long wheelbase van was selected which provides a safe and economical alternative for mobile library service delivery and can be driven on a standard car licence. It will be fitted with a wheelchair lift and solar panels that will charge the onboard battery used to run our computer equipment and offers us more flexibility to deliver library services outside of designated mobile library stops. There are delays to the delivery of some of these items, including the wheelchair lift and we are working closely with Council officers to finalise delivery date and launch event, including an invitation to the Minister.

#### **Torquay Library**

In partnership with Surf Coast Shire the Torquay Library stayed open for longer over the March long weekend as an advertised location for those looking for somewhere cool for respite. This was well received by the community with approximately 240 people finding refuge in the library over the Saturday and Sunday.

#### **Colac Otway**



David Semmens and I enjoyed a day visiting Colac Otway library services including Colac Otway Library, Apollo Bay library and the mobile library service at Corragulac.

Our Colac Library team were part of the celebrations of the 64th annual Kana family festival with a popup library.

The team were thrilled to see 223 people stop by and have a chat. The team offered story time sessions on demand and gave away bookmarks, stickers and book bags as an official stop on the Kana trail.



#### **Waurn Ponds Library**

The importance of collection location and presentation cannot be underestimated and our teams use data as well as good design elements when considering how to display our collections for maximum use by our

customers. An example of this is the recent work all our libraries have undertaken, supported by our collections teams, to reimagine our graphic novel spaces. This is particularly important when we know reading in young people is declining and that this popular genre contributes significantly to literacy development. The recent creation of a new accessible space by the Waurn Ponds Library for Adult Graphic Novels illustrates this; within the first week at the new spot, loans of graphic novels quadrupled.






#### **Wurdi Youang Audio-Visual Technology**

#### **Our Culture Survey**

The outcome of our 2024 Culture Survey, held in February was shared at our recent online All Staff Update. Each team is now meeting and looking at their results and deciding on actions in response to area for improvement for the rest of the year.


There was a high response rate of 80% and this feedback helps us continue to build a strong workplace culture where everyone enjoys coming to work.

Engagement is a measure of how positive people feel about their work and it is the key indicator of our culture. In 2024 we had a favourable Engagement score of 68% which is the percentage of the team that has responded favourably to engagement related questions. This represents an increase of 5% from the previous survey. This is a great result but, to dig a little deeper, you'll note that the percentage of employees who responded unfavourably to engagement related questions has dropped considerably from 16% in 2022 to 7% in 2024. This means that through empowerment, great teamwork, and strong leadership we are focusing on the things that matter to our people and continue making GRLC a wonderful workplace for everyone.



#### **Geelong Aboriginal Employment Taskforce**

Skye Wilson and I attended the third Summit held by the Geelong Aboriginal Employment Taskforce. The theme for the day was First Nations Workforce Planning and Development.

We also attended the annual ABC Radio in Geelong launch. Amelia Dew, our Childrens and Youth Librarian at Lara Library did a fine job sharing the joy of Story Time to audiences around Victoria, with Trevor Chappell on their afternoon program. She backed it up with substance - explaining why we do what we do and how library programs play a vital role in early literacy.

I loved Millie's answer to the question of how you keep toddlers in one space and still - you can't, and that's OK - we want them to enjoy the library!

#### **Kardinia Park Stadium Trust**

I attended the opening of the Joel Selwood Stand as a guest of the Kardinia Stadium Trust, in acknowledgement of our partnership as they work with the Geelong Heritage Centre in preparation for the opening of the Geelong Sports Museum. We currently hold the Dan Dan Nook medal for safe keeping and in consultation with the Wadawurrung Traditional Owners Corporation and the City of Greater Geelong, this will be on display at the Sports Museum, due to open later this year. The event included attendance at the Cats' first AFL match of the year for which I completed a Declaration of Gifts and Hospitality.

#### **Sustainability Victoria**

I was invited to the Sustainability Victoria Networking Event held at Waurn Ponds Estate. This provided an opportunity to discuss various partnership opportunities related to our adult programs, including our established relationship with Sustainability Geelong.

#### **Advocacy**

I met with Minister for Local Government, the Hon. Melissa Horne in my capacity as President, Public Libraries Victoria (PLV) to advocate for funding for public libraries. We discussed the challenges to the budget, and in particular, the advocacy by PLV that includes letters from the community to the Minister and local Members. Last year this campaign was seen as instrumental in freezing the Public Libraries Funding Program (PLFP) at 2023 funding levels, without a further decrease. We also discussed the cut to the Living Libraires Infrastructure Fund to \$2m for the whole state, including the late announcement that makes it difficult for Councils who have already allocated budget.

I let the Minister know that she would receive the attached letter following our meeting and that GRLC is sending similar letters to our local Members. I have since met with or had phone conversations with all our local Members re. funding for public libraries and the challenges for the state Budget in 2025. (Attachment 2).

#### **Bing Doung Province and Becamex by Delegation**

I represented the Cultural and Creative sectors and presented to the delegation at the invitation of the Geelong Chamber of Commerce. The event was held at the KPMG offices and presenters included the Mayor, Cr Sullivan as well as the CEOs of G21 and the Committee for Geelong.

lan presented results for 2022/23 for Geelong regional libraries.

The focus of the presentation:

- To provide information on how well GRLC performed in 2023
- Where do GRLC sit relative to other libraries?
- What do you need to know as you look into the future.

The CEO highlighted the statistic information in the presentation was provided to Craig Kenny which informed his view at the last Board Workshop in December 2023.

lan highlighted the summary was 2022-23 vs 2021-22 (still a year effected by Covid related closures and service capacity wasn't at full capacity)

#### Highlights:

- Geelong high on program attendance "an activity library" strongest level of engagement and performance relative to other libraries.
- Geelong high participation good levels of overall participation, good participation per session for programs; participants want to attend and participate.





GRLC rankings - Library Indicators:

Total library serving funding per capita, Staff EFT per '000 population, Collection, Collection items per capita, Members as % of population, Vistis per capita, Loans/downloads per capita, Turnover rate (loads per physical item), Program attendees per '000 population (onsite).

- IJMS' Victorian library Rankings GRLC is number 1, GRLT is not the best at any single thing, but it is the best at doing all things simultaneously.
- GRLC has been at number 1 position for seven years.

#### Conclusion:

- GRLC is a very good library service because it is best overall.
- COVID changed everything across the whole sector library visitation and collection usage, the sector needs to look forward and create new 'normals'
- Focus on community granular services.
- Keep telling stories the qualitative data is what matters, not the statistics, capture what matters in people's lives and the difference we make at a local level.
